








Q6 Has the property been logged?



Q7 Is the property registered under the Managed Forest Tax Incentive Program (MFTIP)?








Q10 If you have never attended any Huronia Chapter events, why not?




Q12 When do you prefer meetings to be held?


Q13 Do you read the Knothole newsletter?


