Local Site Visits Kick-off Forest Co-op Pilot Project

HWOA members take great pride in their woodlots and know that forest health require some ongoing management. Most members are also part of the MFTIP program and prepare forest management plans. However, we've all seen properties that could use a little TLC.

For a variety of reasons, some forests don't get the attention they deserve. There are many privately-owned 30 – 50 year old conifer plantations in our area that have remained untouched since planting. They are now far too dense with impaired growth. The only ground cover is a heavy layer of pine needles. Conifer plantations were never meant for this fate. One only has to look at the Simcoe County forests where successive harvests of conifers have led to the emergence of mixed hardwood/softwood forests. Hardwood forests also need attention to deal with invasive species and disease.

The problems outlined above seem to exist primary on smaller properties (< 10acres). A harvest may be uneconomic and therefore the owner cannot attract any interest from a logger. Nothing happens as the owner may not know where to turn for help.

The Huronia Community Forest Owners Co-operative Project is a pilot organized by the OWA and the Huronia chapter. The project will bring together forest landowners to develop economies of scale where under-utilized wood fibre in currently orphaned and fragmented conifer plantations or hardwood stands can be harvested for commercial use by the forest industry.

Initial Site Visits

In May, we held our first site visits to four woodlots. In addition to the local team of Jack McFadden, Sandy Agnew and Doug Frost, we were joined by Paul Robertson (OWA president) and Jim Eccles (Huronia Coop project manager). Three of the properties were conifer plantation and one was mixed hardwood. The conifer lots were in close proximity to each other and should be ideal for an initial cut – likely next spring.



Process for Forest Landowners

Once a potential property has been identified, the owner will be contacted and provided with an information kit (project outline document and sample contract). If the owner wishes to proceed, the steps will be as follows:

- Initial site visit by project manager and completion of land inventory
- Preparation of property prescription and financial budget
- Contract between landowner and OWA
- 4) Tree-marking
- 5) Tendering
- 6) Harvesting and supervision
- 7) Completion and revenue sharing

It is hoped that most projects will be revenue positive, but some smaller projects may require an owner contribution in order to cover costs.

Participating landowners will be encouraged to join the OWA and enroll in the MFTIP program if property size allows.





How Can HWOA Members Help?

There are several areas where local HWOA members may be able to help develop the co-op in our region.

- Do you have a woodlot or a part of your property that requires harvesting? Potential woodlots need to be identified for future site visits. If so, please contact any of the project team leaders listed below.
- 2) Are you aware of potential woodlots owned by neighbours or friends who are not OWA members? How about a woodlot where you may not know the owner, but feel that it might be a good candidate? We'd be happy to contact the landowner, participate in an initial meeting and provide an information kit.
- 3) Let others know about the co-op project and the benefits of joining the OWA.
- All participating landowners will become ongoing members of the co-op. This will ensure ongoing

forest management and provide continuous education and interaction between the members. Let us know if you have ideas about how co-op members can work together. One example is accessing maple sap for syrup production by another member.

We will be onsite at the HWOA members Fall Field Day to provide more information and answer questions.
